Assignor hereby unconditionally and irrevocably assigns, grants, transfers, conveys, and delivers exclusively to Assignee, free and clear of any and all liens, encumbrances, and claims of third parties, and Assignee hereby acquires from Assignor ownership and all of Assignor's right, title, and interest in and to the Amereq Marks, all the goodwill associated and symbolized thereby, the registrations therefore, and the right to claim any applicable priority rights arising from the Amereq Marks, whether registered or unregistered, excluding any rights in and to non-Viterra formatives that appear in certain of the Amereq marks, namely, AMEREQ, ROOT-DIP, GELSCAPE, GELSCAPE HYDROGEL TACKIFIER, PLANTA-GEL, AGRI-GEL, AQUATRANT (PAM), BIOZONE, and N-SAVE. All rights in or to the Amereq Marks, including, without limitation, the right to sue for any damages and other remedies in respect of any infringement of any of the Amereq Marks which may have occurred prior to the date of this Assignment, shall be the sole property of Assignee and inure to the benefit of Assignee.
2. Successors and Assigns. This Agreement shall inure to the benefit of and be binding upon Assignor and its respective heirs, successors, licensees and assigns.
