RELEASE OF SECURITY AGREEMENT

This Release of Security Agreement (this "Release") is given as of March 9, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a National banking association, located at One Boston Place, 18th Floor, Boston, Massachusetts 02108 (the "Agent") for the benefit of WINN-DIXIE STORES, INC., a Florida corporation, located at 5050 Edgewood Ct., Jacksonville, Florida 32254 (the "Debtor");

WHEREAS, Debtor has fully discharged and satisfied the obligations secured by the Second Amended and Restated Trademark Security Agreement, dated as of March 18, 2011 ("Security Agreement"). The Security Agreement was recorded in the United States Patent and Trademark Office at Reel 4503/Frame 0960 against the trademark attached hereto as Exhibit A (the "Trademark Collateral"); and

WHEREAS, Debtor has requested that the Agent release, and the Agent is willing to release, subject to the terms hereof, its security interest, and any other right, title and interest it may have in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

Agent does hereby terminate and release, without any recourse, representation or warranty, any and all security interests and all other right, title or interest that it may have in, to or under, the Trademark Collateral and thereby discharge the recordation of the Security Agreement against the Trademark Collateral.
