**RELEASE OF SECURITY AGREEMENT**

This Release of Security Agreement (this "Release") is given as of March 9, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor to First Union National Bank), a National banking association, located at 101 North Phillips Avenue, Sioux Falls, South Dakota 57104 (the "Agent") for the benefit of WINN-DIXIE PROCUREMENT, INC. (by assignment from Monterey Canning Co.), a Florida corporation, located at 5050 Edgewood Ct., Jacksonville, Florida 32254 (the "Debtor");

WHEREAS, Debtor has fully discharged and satisfied the obligations secured by the Trademark Security Agreement, dated as of March 29, 2001 ("Security Agreement"). The Security Agreement was recorded in the United States Patent and Trademark Office at Reel 2284/Frame 0236 against the trademarks attached hereto as Exhibit A (the "Trademark Collateral"); and



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

Agent does hereby terminate and release, without any recourse, representation or warranty, any and all security interests and all other right, title or interest that it may have in, to or under, the Trademark Collateral and thereby discharge the recordation of the Security Agreement against the Trademark Collateral.
