### **RELEASE OF SECURITY INTEREST**

THIS RELEASE OF SECURITY INTEREST having an effective date of February 22, 2012 by The Bank of New York Mellon Trust Company, N.A. (f/k/a BNY Midwest Trust Company) ("Trustee"), in favor of MSX International, Inc. ("Grantor").

WHEREAS, Grantor and Trustee are parties to a certain Trademark Security Agreement dated as of June 6, 2006 (the "Security Agreement"), and recorded in the United States Patent and Trademark Office on March 30, 2007 and recorded at Reel 3554, Frame 0961 under which Grantor granted Trustee a security interest in trademark collateral including but not limited to the trademark registrations and trademark applications listed on Schedule A attached hereto (the "Trademark Collateral"); and

WHEREAS, Grantor has requested that Trustee release the security interest to the Trademark Collateral.

WHEREAS, Trustee desires to assign, release, terminate, discharge, grant, convey, deliver and transfer its continuing security interest in all of the Trademark Collateral to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Trustee hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of the Grantor in, to and under the Trademark Collateral and reassigns and transfers any and all interest that Trustee may have in the Trademark Collateral to the Grantor.

Trustee further agrees to execute and deliver to Grantor any and all further documents and instruments, and do any and all further acts which Grantor (or its agents or designees) reasonably request (at Grantor's sole cost and expense) in order to confirm this Release of Security Interest and Grantor's right, title, and interest in and to the Trademark Collateral.



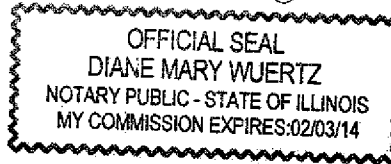
