GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, MCNEELY PLASTIC PRODUCTS, INC., a Mississippi corporation ("Grantor") with principal offices at 1111 Industrial Park Drive, Clinton, Mississippi 39056, hereby grants to PNC BANK, NATIONAL ASSOCIATION ("PNC"), as agent ("Grantee"), a security interest in (a) all of Grantor's right, title and interest in and to the United States trademark number 1857654 registered on October 11, 1994, and the United States trademark number 3307772 registered on October 9, 2007 (collectively, the "Marks", and each, a "Mark"), (b) all proceeds and products of each Mark, (c) the goodwill of the businesses with which each Mark is associated and (d) all causes of action arising prior to or after the date hereof for infringement of each Mark or unfair competition regarding the same.

This Grant is made to secure the satisfactory performance and payment of all the Obligations of Grantor, as such term is defined in the Revolving Credit, Term Loan and Security Agreement among Grantor, the other Persons from time to time party thereto and Grantee, dated as of December 19, 2011 (as amended, modified, restated and/or supplemented from time to time, the "Credit Agreement"). Upon termination of the Credit Agreement as provided therein, Grantee shall execute, acknowledge and deliver to Grantor an instrument in writing releasing the security interest in the Marks acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to Grantee under the Credit Agreement. The rights and remedies of Grantee with respect to the security interest granted herein are as set forth in the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Credit Agreement, the provisions of the Credit Agreement shall govern.


