This agreement shall be binding upon and inure to the benefit of the parties, their successors, assigns and personal representatives.


No modifications or amendments to this agreement shall be valid unless in writing and executed by both parties hereto.

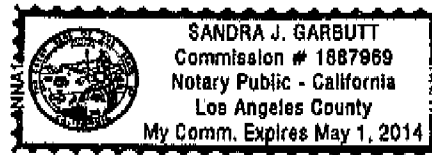
