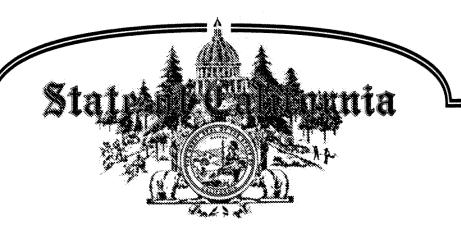

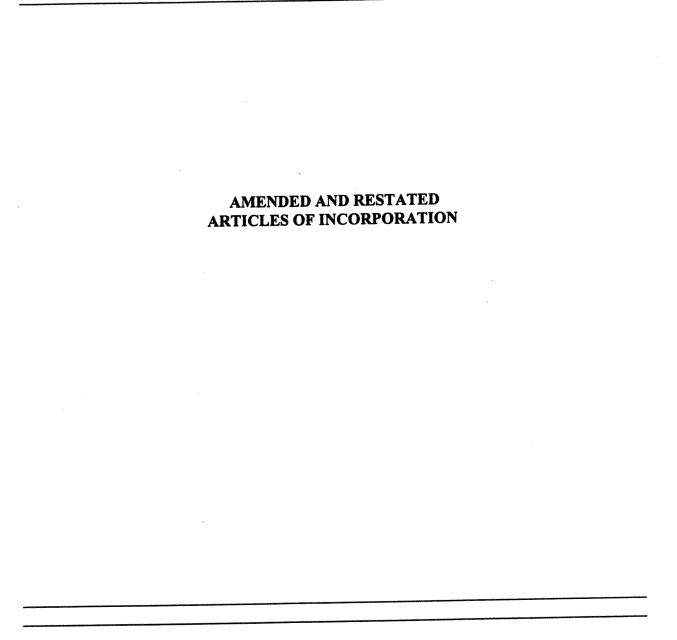

EXHIBIT A

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SUGARLOAF FARMING CORPORATION

ARTICLE I

The name of this corporation is PETER MICHAEL WINERY.

ARTICLE II

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

ARTICLE III

The Corporation is authorized to issue only one class of shares of stock, to be designated Common Stock; and the total number of shares that the Corporation is authorized to issue is 1,000,000.

ARTICLE IV

- (A) The liability of the directors of the Corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.
