CERTIFICATE OF MERGER

M On this 30th day of January, 2012, pursuant to Section 11.02 of the Massachusetts Business Corporation Act (the "BCA") and Section 59 of the Massachusetts Limited Liability Company Act (the "LLCA"), the undersigned hereby certify to the following information relating to the merger (the "Merger") of Perkins Paper, Inc., a Massachusetts corporation, with and into Perkins Paper, LLC, a Massachusetts limited liability company:

1. *Merger and Surviving Company.* On the Effective Date of the Merger (as hereinafter defined): (a) Perkins Paper, Inc., a Massachusetts corporation organized on December 3, 1965 with an office location at 630 John Hancock Road, Taunton, MA ("Perkins, Inc.") shall be merged with and into Perkins Paper, LLC, a Massachusetts limited liability company organized on January 25, 2012 with an office location at 630 John Hancock Road, Taunton, MA 02780 ("Perkins LLC"), (b) Perkins LLC shall be the surviving company, and in such capacity is hereinafter sometimes referred to as the "Surviving Company" and (c) the separate existence of Perkins Inc. shall cease.

2. *Capital Structure of Surviving Corporation.* The Surviving Company is authorized to issue membership interests in the Surviving Company (the "Membership Interests").

3. *Conversion of Shares.* On the Effective Date of the Merger, each share of common stock, no par value, of Perkins Inc. then issued and outstanding shall be converted into and be reclassified as Membership Interests in the Surviving Company so that the owner of all of the outstanding shares of common stock of the Corporation immediately prior to the Effective Date of the Merger shall be the owner of all of the Membership Interests.

3. *Approval.* The Agreement of Merger has been approved by vote of the holders of all of the issued and outstanding shares of stock of Perkins, Inc. and all of the holders of Membership Interests of Perkins LLC and has been executed by Perkins Inc. and Perkins LLC, in accordance with the BCA and the LLCA.

5 4. *Name.* The name of the Surviving Company is Perkins Paper, LLC.

5. *Effective Date of Merger.* As used herein, the term "Effective Date of the Merger" shall mean January 31, 2012.

6. The Agreement and Plan of Merger is on file at the place of business of the Surviving Company at 630 John Hancock Road, Taunton, MA 02780.

7. A copy of this Agreement shall be furnished by the Surviving Company, on request and without cost, to any member of Perkins LLC or stockholder of Perkins Inc.

8. Perkins LLC is managed by its member. The name and business address of its sole member is Snikrep, Inc., 96 Hampton Road, Sharon, MA 02067.

9. Each of Laurence Perkins and Gary Perkins, acting singly, is authorized to execute documents to be filed with the Corporations Division.

10. Each of Laurence Perkins and Gary Perkins, acting singly, is authorized to execute, acknowledge, deliver and record any recordable instrument purporting to affect an interest in real property, whether to be filed with a registry of deeds or a district office of the land court.


11. *Certificate of Organization.* The Certificate of Organization of the LLC, as in effect on the Effective Date of the Merger, shall be the Certificate of Organization of the Surviving Company.

12. *Abandonment.* The merger contemplated by this Agreement may be abandoned by mutual consent and agreement of the Corporation and the LLC at any time prior to the filing of the Articles of Merger with the Secretary of the Commonwealth of Massachusetts.




