**Termination and Release of Lien on Trademarks (the “Release”)**

March 13, 2012 (the “Release Date”)

**WHEREAS**, THE GREAT ATLANTIC & PACIFIC TEA COMPANY, INC., a Maryland corporation (the “Company”) and each subsidiary of the Company listed on Schedule A hereto (individually, a “Grantor” and together with the Company, the “Grantors”), each having principal offices at Two Paragon Drive, Montvale, NJ 07645, each granted a continuing security interest in all of its Trademarks and Trademark Licenses (each, as defined in the Security Agreement referred to below), including those listed on Schedule B hereto, to JPMORGAN CHASE BANK, N.A. as Collateral Agent, with principal offices at 270 Park Avenue, Floor 44, New York, NY 10179 (the “Grantee”) pursuant to that certain Grant of Security Interest in United States Trademarks (the “Grant”) executed in connection with that certain Security Agreement dated as of December 14, 2010 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”; terms defined therein being used herein as therein defined) among the Grantors, the other grantors from time to time party thereto and the Grantee, which security interest was recorded with the United States Patent and Trademark Office (the “USPTO”) on January 12, 2011 at Reel/Frame 004451/0325;

**WHEREAS**, the Grantee has agreed at the request of the Grantors to release its security interest in and lien on the Trademarks and Trademark Licenses;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

SECTION 1. The Grantee does hereby irrevocably terminate, release and discharge any and all security interests in and liens on the Trademarks and Trademark Licenses granted by the Grantors under the Security Agreement and the Grant and does hereby reassign to the Grantors any and all right, title and interest of the Grantee in and to such Trademarks and Trademark Licenses.

SECTION 2. The Grantors hereby acknowledge that the release in Section 1 above is being made without recourse to, or any representation or warranty by, the Grantee.

SECTION 3. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. The Grantee understands and agrees that this Release may be recorded by and for the Grantors with the USPTO and in any other offices

where notices of the Grantee's security interests have been filed and/or the Trademarks or Trademark Licenses have been collaterally assigned to the Grantee.

SECTION 5. The Grantee agrees to execute any other documents and take any further action reasonably necessary in any State, county or jurisdiction that the Grantors and their designees, successors and assigns may reasonably require to effect the intent and purposes of this Release.

SECTION 6. This Release shall be governed by and construed in accordance with the laws of the State of New York (except for the conflict of laws rules thereof, but including General Obligations Law sections 5-1401 and 5-1402).









