TRADEMARK ASSIGNMENT

No other rights, immunities, or licenses, including, without limitation, any rights to any intellectual property owned, controlled or licensable by Assignor are granted or assigned to Assignee under this Assignment, either expressly or by implication, estoppel, or otherwise, other than the rights expressly recited herein.

Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would knowingly conflict with this Assignment.

Assignor further covenants that Assignee will, upon its lawful request, reasonably be provided with all pertinent facts and documents relating to the Assigned Trademark Rights and legal equivalents as may be known and reasonably accessible to Assignor and that Assignor will testify as to the same in any administrative contest or litigation related thereto and will promptly execute and deliver to Assignee or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce the Assigned Trademark Rights and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
