CONFIRMATION OF TRADEMARK ASSIGNMENT

This Confirmation of Trademark Assignment ("**Assignment**") is entered into by and between Arch Rock LLC a Delaware Limited Liability Company ("**Arch Rock**"), and Cisco Systems, Inc., a California corporation ("**CSI**").

NOW, THEREFORE, Arch Rock and CSI agree as follows and confirm that:

"Arch Rock Marks" means all of Arch Rock's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Arch Rock's trademark registrations and applications (except for Arch Rock's Intent-to-Use U.S. applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the U.S. Patent and Trademark Office) and any and all of Arch Rock's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the mark identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Arch Rock has assigned and transferred, and CSI has received and accepted, all of Arch Rock's rights, title and interest throughout the world in and to the Arch Rock Marks and all the rights, claims and privileges pertaining to the Arch Rock Marks, including without limitation: the registrations and applications pertaining thereto (except for Arch Rock's Intent-to-Use U.S. applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the U.S. Patent and Trademark Office), together with all of the goodwill of the business associated with and symbolized by the Arch Rock Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Arch Rock in all matters related thereto.

Arch Rock hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign countries to implement this Assignment.

IN WITNESS WHEREOF, Arch Rock and CSI have caused this Assignment to be made as of the effective date of the Asset Transfer Agreement referenced above.
