TERMINATION AND RELEASE OF SECURITY INTEREST

This Termination and Release of Security Interest is effective as of December 7, 2011, and is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Lender"), acting through its Wells Fargo Business Credit operating division.


WHEREAS, a certain Patent and Trademark Security Agreement, dated as of December 5, 2003 (the "IP Security Agreement"), was executed in favor of the Lender by The Producto Corporation, a Michigan corporation, Moore Tool Company, Inc., a Connecticut corporation, Moore Nanotechnology Systems, LLC, a Connecticut limited liability company, PMT Group, Inc., a Connecticut corporation, Moore Land Company, Inc., a Connecticut corporation and Producto Diemakers Supplies Limited, an Ontario corporation (each a "Grantor" and collectively the "Grantors"), pursuant to which one or more Grantors granted to the Lender a security interest in such Grantor's Patents and/or Trademarks, as defined in the IP Security Agreement, and as set forth in Annex A and Annex B attached hereto, respectively; and

WHEREAS, the corresponding Notice of Assignment For Security (Patents), dated as of December 5, 2003, was recorded on February 3, 2004 with the United States Patent and Trademark Office at Real/Frame 014301/0164 and at Real/Frame 014301/0170 and the corresponding Notice of Assignment For Security (Trademarks), dated as of December 5, 2003, was recorded on January 29, 2004 with the United States Patent and Trademark Office at Real/Frame 2785/0640, and on February 25, 2004 with the United States Patent and Trademark Office at Real/Frame 2788/0144.

NOW, THEREFORE, intending to be legally bound hereby, the Lender hereby releases and terminates any and all rights, title and interests in and to the Patents and Trademarks, and hereby authorizes each Grantor or its authorized representative to record this Termination and Release of Security Interest with the United States Patent and Trademark Office.
