INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of January ~~3rd~~ 2012 (the "Effective Date") between **A&S Brewing Collaborative LLC**, a Delaware limited liability company with a principal place of business at 209 Battery Street, Burlington, VT 05402 (together with its parents, subsidiaries and affiliates, "A&S"), and **Southern California Brewing Co., Inc. DBA Angel City Brewing**, a California corporation with a principal place of business at 216 South Alameda Street, Los Angeles, CA 90012 ("SCBC").

WHEREAS, SCBC is the owner of the trademarks (the "Marks") and other intellectual property ("the Property") as described in Exhibit A, attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby in connection with the goods and services upon which the Marks are used ("the Products").

WHEREAS, A&S has determined to purchase all of the assets, including all intellectual property assets, of SCBC for good and valuable consideration as part of an "Asset Purchase Agreement," the terms of which are incorporated by reference herein;

WHEREAS, SCBC desires to convey, transfer, assign, deliver, and contribute to A&S all of its right, title, and interest in and to all of SCBC's intellectual property assets, including but not limited to the Marks and the Property (collectively, the "SCBC IP Assets"), as part of the Asset Purchase Agreement;

NOW, THEREFORE, in consideration of the amounts paid by A&S to SCBC in connection with the Asset Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, SCBC hereby conveys, transfers, assigns, delivers, and contributes to A&S all of SCBC's right, title, and interest of whatever kind in and to the SCBC IP Assets, including but not limited to the Marks and the Property, together with: (1) the goodwill of the business relating to the Products in respect upon which the Marks are used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to SCBC with respect to the SCBC IP Assets, including without limitation, damages and payments for past or future infringements, misappropriations, and/or other violations of the SCBC IP Assets; and (3) all rights to sue for past, present, and future infringements, misappropriations, and/or other violations of the SCBC IP Assets.

SCBC further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in A&S the full right, title, and interest in the SCBC IP Assets, including but not limited to the Marks and the Property.

IN WITNESS WHEREOF, A&S and SCBC have caused this Agreement to be duly executed on their behalf, as of the Effective Date.
