TERMINATION AND RELEASE OF SECURITY AGREEMENT dated as of March 16, 2012, by COBANK, ACB, a federally chartered instrumentality of the United States (the "Secured Party").

WHEREAS, NORBEST, INC., a Utah corporation (the "Debtor"), and the Secured Party entered into a Security Agreement, dated as of May 16, 2011 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on May 26, 2011, at Reel 004549, Frame 0401 for the purpose of collateral security for all indebtedness and obligations of the Debtor to the Secured Party;

WHEREAS, pursuant to the Security Agreement, the Debtor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Collateral (as defined in the Security Agreement) including, without limitation, the trademarks listed on Exhibit A hereto (the "Trademarks"). 

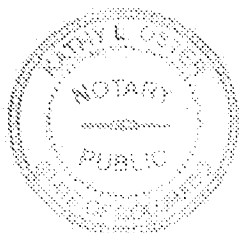
