RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (“**Release**”), dated as of February 29, 2012 (“**Effective Date**”) confirms the termination and release of the Lien (as defined hereunder) granted to Wilmington Trust, National Association, as administrative agent (“**Wilmington Trust**”).

WHEREAS, in connection with the Second Lien Credit Agreement, dated April 15, 2011 (as amended, restated, supplemented, or otherwise modified from time to time) (“**Credit Agreement**”), Golden Gaming, Inc., Golden Tavern Group, LLC, Golden Mardi Gras, Inc. and Golden Pahrump Nugget, LLC (collectively, the “**Grantors**”) executed and delivered the Intellectual Property Security Agreement, dated April 15, 2011 (“**Security Agreement**”), through which the Grantors granted to Wilmington Trust, a security interest in and to all of such Grantors’ rights, title and interest in and to the Collateral (as defined in the Security Agreement), including the intellectual property set forth in attached **Schedule A** (“**Lien**”);

WHEREAS, the Trademark Security Agreement was recorded at Reel 4524 and Frame 0936 on April 19, 2011 in the United States Patent and Trademark Office;

WHEREAS, the Patent Security Agreement was recorded at Reel 026165 and Frame 0567 on April 21, 2011 in the United States Patent and Trademark Office;

WHEREAS, through a letter dated February 29, 2012 (“**Letter**”), Wilmington Trust has confirmed and acknowledged the release of the Lien against the Collateral, and this Release is intended to confirm the release and termination of all liens, security interests, and other encumbrances in and to the Collateral created under the Security Agreement in favor of Wilmington Trust.


NOW, THEREFORE, pursuant to foregoing and subject to the Letter, Wilmington Trust agrees and confirms as follows:

1. This Release confirms that the entire Lien granted to Wilmington Trust under the Security Agreement, including in the Collateral set forth in **Schedule A** attached hereto, are released and permanently terminated.
2. This Release is intended to be recorded in the United States Patent and Trademark Office or any other office(s) or government entities to confirm and evidence the foregoing release and termination of the Lien created under the Security Agreement.
