## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE, dated as of February 29, 2012 ("**Effective Date**"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as successor-in-interest to Bank of America, N.A. ("**Bank of America**"), in its capacity as Administrative Agent ("**Wilmington Trust**") pursuant to the Third Amended and Restated Credit Agreement, dated April 15, 2011, among Golden Gaming, Inc., Golden Mardi Gras, Inc. and Golden Pahrump Nugget, LLC, Wilmington Trust as Administrative Agent and the lenders from time to time party thereto (the "**Lenders**") (the "**Credit Agreement**").

WHEREAS, Golden Gaming, Inc. and Golden Mardi Gras, Inc. ("**Grantors**") and certain affiliates of Grantors are parties to the Security Agreement, dated January 25, 2005 ("**Security Agreement**"), and granted a security interest to Bank of America and the Lenders in certain intellectual property, including the Trademark Collateral (defined below);

WHEREAS, the Grantors subsequently executed (i) the Amended and Restated Security Agreement, dated November 8, 2006 ("**Amended and Restated Security Agreement**") and recorded with the U.S. Patent and Trademark Office on February 26, 2007 at Reel/Frame No. 3488/0686, and (ii) the Reaffirmation of Amended and Restated Security Agreement, dated May 8, 2009 ("**Reaffirmation of Security Agreement**") and recorded with the U.S. Patent and Trademark Office on May 14, 2009 at Reel/Frame No. 3987/0793, pursuant to which the Grantors granted to Bank of America a security interest in all presently existing and hereafter acquired Collateral (as defined in the Security Agreement), including the intellectual property set forth in attached Schedule A ("**Trademark Collateral**");

WHEREAS, pursuant to the Successor Agent Agreement dated August 4, 2011, Bank of America resigned as the existing Administrative Agent, and Wilmington Trust succeeded and was vested with all the rights, powers, privileges and duties of Bank of America, and Wilmington Trust assumed the obligations, responsibilities and duties of Bank of America as Administrative Agent in accordance with the terms thereof;

WHEREAS, as of the date hereof, (i) Golden Mardi Gras, Inc. has sold, transferred, assigned and conveyed all of its assets, properties and businesses to a third party purchaser, (ii) in connection with the amendment and restatement of each of the Credit Agreement and the Amended and Restated Security Agreement on the date hereof, Golden Mardi Gras, Inc. has been released as a "Borrower" under the Credit Agreement and a "Grantor" under the Amended and Restated Security Agreement and (iii) the Administrative Agent and the Lenders' security interest in all Collateral, including intellectual property, of Golden Mardi Gras, Inc. has been terminated;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wilmington Trust agrees as follows:


Wilmington Trust, on its own behalf and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Security Agreement, the Amended and Restated Security Agreement, the Reaffirmation of Security Agreement or otherwise, in and to the trademarks listed on Schedule A attached hereto and incorporated herein by reference ("**Released Collateral**").

The parties hereto shall cause this Release to be filed with the U.S. Patent and Trademark Office for the purpose of recording the release of the Secured Parties' security interest in the Released Collateral.

Wilmington Trust agrees to provide the Grantors with any additional authorization necessary to effect the release of its security interest in the Released Collateral.

IN WITNESS WHEREOF, Wilmington Trust has caused this Release to be executed by a duly authorized signatory, to be effective as of the Effective Date.
