**TERMINATION AND RELEASE**  
(Trademarks)

This TERMINATION AND RELEASE is dated as of September 29, 2011, and made by FIRST AMERICAN BANK, an Illinois banking corporation (the "Secured Party"), in favor of ROADS SAFE HOLDINGS, INC., a Delaware corporation (the "Pledgor").

WITNESSETH:

WHEREAS, the Pledgor granted a security interest in certain Collateral (as hereinafter defined) to the Secured Party (the "Security Interest"); and

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on June 19, 2009 at Reel 004008, Frame 0582; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby terminates and releases the Security Interest in the Collateral, without any representation, recourse or undertaking by the Secured Party, as follows:

Collateral. The term "Collateral," as used herein, shall mean all of the Pledgor's right, title and interest of every kind and nature in the trademarks set forth on Schedule A attached hereto and (i) all registrations, applications, recordings and rights relating thereto; (ii) all reissues, continuations, continuations-in-part or extensions thereof/ all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or receivable with respect thereto, including, without limitation, all damages and payments receivable for past, present and/or future infringements thereof; (iv) the right to sue for past, present and/or future infringements thereof; (v) all rights corresponding thereto throughout the world; and (vi) the goodwill of the Pledgor's business connected with or symbolized by the foregoing.
