TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is made as of March 9, 2012 (the "Effective Date") by and between Quality Culvert, Inc., a Wisconsin corporation whose mailing address is at 205 North Street, P.O. WHEREAS, Assignor authorizes and requests the United States Commissioner of Patents and Trademark to issue all trademark registrations and renewals which may issue with respect to the Trademarks to Assignee, its successors and assigns, in accordance with this Assignment.

AND, Assignor HEREBY covenants that Assignor has not and will not execute any agreement in conflict with this Assignment.
