**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination and Release") is made as of the 12 day of March 2012, by American Capital, Ltd. (as successor in interest to American Capital Financial Services, Inc.) in its capacity as Agent pursuant to the Note and Equity Purchase Agreement (as defined below) (in such capacity, the "Agent") in favor of Lifoam Holdings, Inc., a Delaware corporation (as successor in interest to Life-Like Holdings, Inc.) ("Holdings"), Lifoam Acquisitions, Inc., a Delaware corporation (as successor in interest to Life-Like Acquisitions, Inc.) ("Acquisitions"), Lifoam Industries, LLC, a Delaware limited liability company (as successor in interest to Life-Like Products, LLC) ("Industries" and together with Holdings and Acquisitions, the "Grantors" and each individually a "Grantor"). Capitalized terms not otherwise defined herein, shall have the meanings ascribed to them in the Note and Equity Purchase Agreement.

**WITNESSETH:**

**WHEREAS**, in connection with that certain Second Amended and Restated Note and Equity Purchase Agreement, dated June 30, 2009 (the "Note and Equity Purchase Agreement"), by and among Holdings, Acquisitions, Industries, Lifoam Packaging Solutions, LLC, a Delaware limited liability company ("Solutions"), Envirocooler, LLC, a Delaware limited liability company ("Envirocooler"), Agent and certain purchasers, each Grantor entered into a Trademark Security Agreement (as defined below) and Security Agreement (as defined below);

**WHEREAS**, pursuant to that certain Trademark Security Agreement ("Trademark Security Agreement"), dated as of June 15, 2004, among Holdings, Acquisitions, Industries and Agent, each Grantor granted to the Agent, a security interest in all Grantor's right, title, and interest in, to and under its trademarks to which it is a party ("Trademark Collateral"), as described in Schedule 1;

**WHEREAS**, pursuant to that certain Security Agreement ("Security Agreement"), dated as of June 15, 2004, among Industries, Holdings, Acquisitions, Solutions, Envirocooler and Agent, each Grantor granted to the Agent, a security interest in Trademark Collateral; and

**WHEREAS**, the Agent has agreed to release and terminate all collateral pledges, grants, assignments, liens and security interests in the pledged Trademark Collateral.

**NOW, THEREFORE**, in consideration of the premises and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Agent, on behalf of the lenders, does hereby release and terminate all collateral pledges, grants, assignments, liens and security interests in the pledged Trademark Collateral.

2. The Agent hereby agrees, at the expense of the Grantors, to take any reasonable actions and to execute, acknowledge, procure and deliver any further documents necessary or reasonably requested by the Grantors to effectuate, record or evidence the release of the Agent's security interest in the Trademark Collateral.


3. The Agent authorizes the Grantors to request that the United States Patent and Trademark Office record this Termination and Release against the Trademark Collateral.

4. This Termination and Release shall be governed by the law of the State of New York.
