AMENDMENT TO
TECHNOLOGY & TRADEMARKS PURCHASE AGREEMENT

This *Amendment to Master License Agreement* (the "Amendment") is made by and between Rhodia Inc., a corporation organized and existing under the laws of Delaware, U.S.A., and having its principle office located at 8 Cedar Brook Drive, Cranbury, NJ, 08512, and Rhodia Operations, a société par actions simplifiée incorporated and operating under the laws of France with its principal office located at 40 Rue de la Haie Coq 93308 Aubervilliers, France (the "Parties").

Effective January 1, 2006, Rhodia Inc. and Rhodia Recherches et Technologies entered into a *Technology and Trademarks Purchase Agreement* (the "Purchase Agreement") and a *Master License Agreement* (the "License Agreement"). Effective July 1, 2007, Rhodia Recherches et Technologies was merged into Rhodia Operations and Rhodia Operations is thus successor in interest to Rhodia Recherches et Technologies with respect to the Purchase Agreement and the License Agreement.

The first paragraph of the Purchase Agreement erroneously indicates, in the definition of the term "SELLER", that Rhodia Inc. is a corporation duly organized and existing under the laws of the State of New Jersey, U.S.A. The Parties now wish to correct that error by correctly indicating that Rhodia Inc. is a corporation duly organized and existing under the laws of the State of Delaware, U.S.A.

Rhodia Inc. agreed, under Paragraph 2.1 of the Purchase Agreement, to assign its rights in certain SELLER Technology to Rhodia Recherches et Technologies in exchange for consideration to be paid in accordance with Article 5 of the Purchase Agreement. The Parties now wish to clarify the definition of "SELLER Technology" to reflect that Rhodia Inc. technology arising after the Effective Date of the Purchase Agreement is included in the Purchase Agreement only to the extent listed in Annex 1 or Annex 2 to the Purchase Agreement. The Parties have, in an *Amendment to Master License Agreement* signed on the same day herewith, amended the License Agreement to address the assignment of rights in Rhodia Inc. intellectual property, other than that listed in Annex 1 or Annex 2 of the Purchase Agreement, arising after the Effective Date of the Purchase Agreement.

Accordingly, the Parties now wish to, effective as of the Effective date of the License Agreement, amend the Purchase Agreement as follows, with all other terms of the Purchase Agreement to remain unchanged.

A. Amend the definition of the term "SELLER" in the first paragraph of the Purchase Agreement to read as follows:

Rhodia Inc., a corporation duly organized and existing under the laws of the State of Delaware, U.S.A., and having its principle office located at 8 Cedar Brook Drive, Cranbury, NJ 08512-7500 (hereinafter the "SELLER").

B. Amend Paragraph 1.8 of the Agreement to read as follows:

1.8 "SELLER Technology" shall mean and include any and all existing SELLER IP as well as R&D results, knowledge, including trade secret knowledge, documentation relating to processes, services, technical information, and any other information in any format which is useful or necessary for the development, and/or manufacture, and/or marketing of the SELLER's Products, including know-how which was developed based on RR&T's know-how and other technical information, in whatever form, tangible or intangible, (i) in existence as of the Effective Date, or (ii) arising after the Effective Date and listed in Annex 1 or Annex 2 of this Agreement.

C. Revise Paragraph 2.1 of the Purchase Agreement to add the following sentence:

SELLER reserves the right to transfer rights in certain SELLER Technology to:

Le Centre National de la Recherche Scientifique, a public institution for science and technology organized and existing under the laws of the Republic of France ("CNRS") with offices located at 3, rue Michel Ange 75794 Paris, Cedex 16, France, or

Schlumberger Technology Corporation, having a principal place of business at 110 Schlumberger Drive, Sugar Land, TX 77478, and its affiliates ("SLB"),

to the extent required to satisfy SELLER'S pre-existing obligations to CNRS and to SLB, respectively.

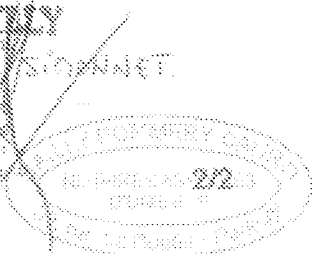

TECHNOLOGY & TRADEMARKS PURCHASE AGREEMENT

* * *

This TECHNOLOGY & TRADEMARKS PURCHASE AGREEMENT ("Agreement") is made and entered into effective as of 1st January, 2006 ("Effective Date") by and between:

Rhodia INC. a company duly organized and existing under the laws of the State of New Jersey, with its registered office at 8 Cedar Brook Drive, CN 7500, 08512-7500, Cranbury (hereafter, the "SELLER"),

AND,

Rhodia Recherches et Technologies ("RR&T") a *société par actions simplifiée* incorporated and operating under the laws of France with its principal office located at 52 Rue de la Haie Coq 93300 Aubervilliers, registered under number 322 346 669 RCS Bobigny, (hereafter, the "PURCHASER").

Hereafter, the SELLER and PURCHASER are referred to as the "Parties" to this Agreement.

In reference to the following facts:

WHEREAS, the Parties are affiliates of Rhodia, a company duly organized and existing under the laws of France, and are part of the Rhodia Group;

WHEREAS, the Parties entered into a Memorandum of Understanding ("MOU") effective January 2nd, 2006 whereby they agreed in good faith to promptly put in place a new Rhodia Group worldwide Rhodia Research and Development ("R&D") and related engineering and technology licensing policy effective as of the date of effect of the MOU;

WHEREAS, the Parties acknowledge the "Master Agreement Between Rhodia Recherches et Technologies And Rhodia Group Companies" (hereafter the "Master Agreement") whereby the Rhodia Group agreed that RR&T was entrusted with the management of the Rhodia Group's worldwide R&D processes and engineering resources located in research centers or at decentralized laboratories or at engineering departments on industrial production sites or at field marketing locations worldwide;

WHEREAS, RR&T, acting as the Rhodia Group's central R&D management location, is also the LICENSOR and/or sub-licensor for all Rhodia France's Intellectual Property ("IP") and Technology;

WHEREAS, the SELLER is the developer and owner of certain technology, Intellectual Property ("IP") rights and confidential information related to the design,

development and manufacture of Rhodia Products for Rhodia Group's worldwide Novecare Enterprise;

WHEREAS, the PURCHASER wishes to acquire all rights related to such SELLER owned Trademarks and Technology and IP rights (as defined herein) and any related confidential information related to the SELLER's Novecare Research and Development ("R&D") activity;

WHEREAS, the SELLER is willing to transfer to the PURCHASER for an arm's length purchase price all rights to such SELLER owned Home, Personal Care and Industrial Ingredients ("HPCI") Business Unit ("BU") and Phosphorus and Performance Derivatives ("PPD") BU Trademarks as well as Novecare Enterprise developed technology, IP rights and other confidential information in accordance with the terms and conditions of this Agreement;

WHEREAS, the SELLER and the PURCHASER have entered into a license for valuable RR&T technology, IP rights and other confidential information, as well as valuable Trademarks under the Master License Agreement ("MLA") and hence the acquisition of all rights granted to the PURCHASER under this Agreement will be henceforth subject to the contractual understanding (terms and conditions) of the MLA whereby the PURCHASER agrees to include all purchased technology and rights under the MLA and compensate the SELLER's international R&D costs (under the terms and conditions specified in the MLA); and,

WHEREAS, the Parties agree that all IP and know-how related to other Rhodia Enterprises, specifically the Acetow and the Eco Services Enterprises, as well as any IP and know related to the Silcones BU, is expressly excluded from the scope of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

The Parties hereby agree as follows:

Article 1: Definitions

For the purposes of this Agreement, the following terms shall have the following meanings:

- 1.1 "Affiliate" shall mean another entity which directly or indirectly controls, is controlled by, or is under common control with the original entity. The term "Control" means the ownership of at least 50 percent of the share capital and/or of the voting rights.
- 1.2 "Rhodia Group" shall mean Rhodia SA and all of its worldwide affiliates.
- 1.3 "Rhodia France" shall mean RR&T and all other affiliates in France.
- 1.4 "Market Sector" shall mean the technical domain and business expertise of the SELLER related to Novecare (as defined under Rhodia Group's global management organization).

- 1.5 "Products" shall mean the Rhodia Novicare products developed by the SELLER's R&D activity.
- 1.6 "Patents" shall mean all SELLER owned patents, including reissues, divisions, renewals and extensions thereof, including any patents currently in the process of being filed or filed but not yet issued, and any and all rights derived there from and all reissues, divisions, renewals and extensions thereof related to all of the SELLER's patent portfolio, including patents specific to the SELLER's Market Sector and Products as well as miscellaneous patents (excepting the excluded Enterprises and BU). Annex 1 lists the SELLER's patents covered by this Agreement.
- 1.7 "Intellectual Property Rights" or "IP Rights" or "IP" shall mean any and all patents, other proprietary rights (trade secret knowledge), and all applications and registrations thereof, which relate to, are embodied or incorporated in, or are used in conjunction with the Market Sector and Products as well as SELLER owned Novicare-related Trademarks (as listed in Annex 2 to this Agreement). Included within the scope of IP rights are all confidential information and data related to the SELLER's Market Sector and Products.
- 1.8 "SELLER Technology" shall mean and include any and all existing SELLER IP as well as R&D results, knowledge, including trade secret knowledge, documentation relating to processes, services, technical information, and any other information in any format which is useful or necessary for the development, and/or manufacture, and/or marketing of the SELLER's Products, including know-how which was developed based on RR&T's know-how and other technical information, in whatever form, tangible or intangible, in existence as of the Effective Date or arising after the Effective Date while this Agreement is in force, and all updates, enhancements, improvements, and modifications thereto, relating to design, development, manufacture, operation, maintenance and/or repair of any or all the Products.

Article 2: Sale of Technology & Trademarks

- 2.1 SELLER hereby agrees under this Agreement to hereby sell, transfer and assign to the PURCHASER without reservation or exception, and the PURCHASER hereby accepts, purchases, and acquires all of the SELLER's rights, title and interest related to the SELLER's Technology as of the effective date of this Agreement subject to the terms and conditions stated herein, as well as SELLER-owned Trademarks (trade names) listed in Annex 2.
- 2.2 The assignment of the Patents shall be effective on the effective date of this Agreement (the "Effective Date").
- 2.3 As a consequence the PURCHASER shall, as from the Effective Date, be vested with all rights over the Patents previously held by the SELLER.
- 2.4 The PURCHASER shall therefore hold all rights of ownership and use over the Technology (that is IP, including Patents) and shall be entitled to assign them, use them, maintain them or abandon them as it wishes.

- 2.5 In case the PURCHASER wishes to maintain the Patents, it shall pay the annuities as from the Effective Date.
- 2.6 This assignment shall entail the right for the PURCHASER to bring legal claims for Patents infringement in respect of all acts of infringement, whether occurring prior to or after the Effective Date.

Article 3: SELLER's Responsibilities

- 3.1 SELLER commits to provide all necessary information to allow the PURCHASER to carryout its responsibilities as the legal owner of Technology.
- 3.2 As soon as practically possible, but in no event later than thirty (30) days after the date of execution of this Agreement, SELLER shall transfer to PURCHASER all relevant documentation in its possession relating to the IP, including patents (including but not limited to filings, registration certificates, letters with the relevant industrial property institutes, proof of payment of annuities, internal files, etc.).

Article 4: PURCHASER's responsibilities

- 4.1 PURCHASER hereby agrees that it allows SELLER to use all Novecare Market Sector and Product know-how and related IP, including the valuable Rhodia Trademarks (trade names and marks) as well as Novecare-related Trademarks (trade names and related marks) and as long SELLER complies with the terms and conditions of the MLA, separately entered into by the Parties.
- 4.2 The formalities relating to the assignment of the Patents provided for in this Agreement shall be effected with all relevant registers. These formalities shall be effected by the PURCHASER who shall bear all related fees and expenses. The SELLER undertakes to sign all documents, complete all necessary steps, and provide all lawful cooperation in order to allow the PURCHASER to proceed with the registration of this assignment in any register concerned, to perfect the PURCHASER's title in and to the transferred Patents worldwide, and to otherwise carry out and fulfil the purposes and intent of this Agreement.
- 4.3 The registration of this Agreement with the tax administration shall be effected by the PURCHASER who shall pay all registration duties arising there from.

Article 5: Consideration to be paid


- 5.1 In consideration for the sale of the Novecare Technology and Trademarks, PURCHASER will compensate the SELLER the amount as defined at Annex 3.
- 5.2 The PURCHASER agrees that the amount determined in Annex 3 is the entire compensation due for any and all rights sold under this Agreement.

Article 6: General Provisions

- 6.1 Notices: All notices, reports and other communications between the parties shall be sent by registered air mail, postage prepaid and return receipt requested, or by

facsimile with a confirmation sent by registered air mail to the address set forth at the beginning of this Agreement or to such other addresses as the parties may designate by written notice from time to time. Each such notice, report, or other communication shall be effective upon receipt by the sender of confirmation of the delivery, or where no such confirmation is possible, when received.

- 6.2 Choice of Law and Forum: This Agreement shall be governed by and construed and enforced in accordance with the laws of France. Any dispute, controversy or claim arising out of, or in connection with this Agreement or the breach, termination or validity thereof, which cannot be resolved by good faith discussions between the Parties shall be submitted to the Tribunal de Grande Instance de Paris..
- 6.3 Headings: The subject headings of this Agreement are included for purposes of convenience only, and shall not affect the construction or interpretation of any provision of this Agreement.
- 6.4 Counterparts: This Agreement may be executed in several duplicates, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- 6.5 Waivers: The failure by either party to assert any of its rights hereunder, including but not limited to, the right to terminate this Agreement due to a breach or default by the other party hereto, shall not be deemed to constitute a waiver by that party of its rights thereafter to enforce each and every provision of this Agreement in accordance with its terms.
- 6.6 Relation with the Multi-Creditor Security Agreement: Notwithstanding anything to the contrary herein contained (i) the SELLER and the PURCHASER acknowledge that under the terms of that certain Multi-Creditor Security Agreement dated July 29, 2005 amongst the SELLER, other Grantor parties thereto, and Wilmington Trust Company, as Collateral Agent (the "MCSA"), the SELLER has granted a first priority lien (the "MCSA Lien") to the Collateral Agent (as defined in the MCSA) in Trade Secrets Collateral (as that term is defined in the MCSA, excerpted below) in relation to the operation and use of certain plants and equipment located on, or related to, the plant sites listed below (the "MCSA Collateral"), (ii) the SELLER and the PURCHASER hereby agree that to the extent any intellectual property rights which are being sold, assigned or otherwise transferred hereunder by SELLER to PURCHASER constitute MCSA Collateral ("Overlap IP"), such Overlap IP is sold, assigned or otherwise transferred hereunder subject to the MCSA Lien, (iii) SELLER and PURCHASER hereby agree that the Overlap IP will remain subject to the MCSA Lien at all times unless the MCSA Lien is released in accordance with all relevant provisions of the MCSA and the Credit Agreement (as defined in the MCSA), (iv) each of SELLER and PURCHASER agrees that it will, from time to time and at its own expense, promptly execute and deliver all further instruments and documents, and take all further action, that may be necessary or desirable, or that the Collateral Agent may reasonably request, in order to perfect, preserve and protect the Collateral Agent's security interest in the Overlap IP or to enable the Collateral Agent to exercise and enforce its rights and remedies hereunder with respect to any Overlap IP in all relevant jurisdictions, (v) the SELLER hereby represents for the benefit of the Collateral Agent that the MCSA Lien in the Collateral (as defined in the MCSA)

continues in full force and effect and remains perfected in accordance with the terms of the MCSA and the Credit Agreement, (vi) the SELLER in its capacity as *stipulant* stipulates and the PURCHASER in its capacity as *promettant* promises to the benefit of the Collateral Agent and each other Secured Party (as defined in the MCSA) as beneficiaries that the Collateral Agent and each other Secured Party (as defined in the MCSA) shall be entitled, in accordance with articles 1121 and 1122 of the French Civil Code to rely on all the terms of this Section. Each of the Collateral Agent and other Secured Party (as defined in the MCSA) shall accept such *stipulation pour autrui* and the SELLER will inform the PURCHASER of the identity of the Collateral Agent and each other Secured Party (as defined in the MCSA) from time to time.


