**Declaration of Frederick P. Furth**

I, individually and doing business as Chalk Hill Estate Winery, am the registrant of the trademarks captioned above (the "Trademarks").

The Trademarks are subject to a security agreement with IBJ Schroder Bank & Trust Company. IBJ Schroder Bank & Trust Company changed its name in July of 1999 to IBJ Whitehall Bank and Trust Company. Thus, title to the Trademarks show outstanding security interests originally made to IBJ Schroder Bank & Trust Company, which now stands in the name of IBJ Whitehall Bank and Trust Company.


Research indicates that IBJ Whitehall Bank and Trust Company merged into the Industrial Bank of Japan Trust Company, which in turn merged into Mizuho Corporate Bank (USA). None of these mergers to the various Japanese banks were filed with the United States Patent and Trademark Office in connection with the above-captioned registrations. As Mizuho did not record the security interests, they may not be able to provide adequate confirmation to remove the security interest.

The security interests have never been removed from the record. I have paid in full all outstanding obligations and payments due under the security agreements which gave rise to the security interests now encumbering the Trademarks. Given the multiple mergers described above, I cannot access appropriate representatives of Mizuho to obtain a release.

Therefore, this letter constitutes notice to the USPTO that the security interests have been extinguished. Please note on the record of each of the Trademarks that unencumbered title to the Trademarks rests with Frederick P. Furth.
