**RELEASE AND ASSIGNMENT OF SECURITY INTEREST**

For Ten (\$10.00) Dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged,

**Wells Fargo Bank, National Association**, acting for itself and in its capacity as administrative agent for certain Lenders (said Agent and Lenders hereinafter the "Releasor") which Lenders are described and named as the "Secured Parties" in an Agreement entitled "Patent, Trademark & Copyright Security Agreement" that was entered into on October 27, 2008, between and among said Releasor as secured parties, on the one hand, and Viking Range Corporation, a Mississippi corporation with offices at 111 Front St, Greenwood, MS, as the Grantor of certain security interests to said Releasor, on the other hand, all as set forth in more detail in the copy of said Agreement which is recorded at the United States Patent and Trademark Office on October 31, 2008, at Reel 3881, Frame 0183, (said Agreement as amended prior to the date hereof is hereinafter referred to as the "Security Agreement");

**HEREBY RELEASES** and discharges said **Viking Range Corporation, its subsidiaries, affiliates, successors and assigns** from any security interest, or collateral assignment in favor of said Releasor created under said Security Agreement as and to the extent, but only to the extent, said security interest or collateral assignment created under said Security Agreement burdens, encumbers or affects in any way the following described trademarks, trademark registrations and intellectual property (collectively, the "Released Trademarks"):

U.S. Trademark Registration No. 0758839 for the mark ST CHARLES

U.S. Trademark Registration No. 2158484 for the mark ST CHARLES

U.S. Trademark Registration No. 3583027 for the mark ST CHARLES

Together with and including from the scope of this release any other trademarks, copyrights or other intellectual property (excluding patents and any intellectual property relating to or used in connection with the "Viking" brand or the ongoing businesses of Viking Range Corporation and its subsidiaries) used or intended to be used solely in connection with the manufacture, sale or marketing of kitchen cabinets under the ST CHARLES trademarks or brand.

**AND RELEASOR FURTHER HEREBY ASSIGNS** and conveys to said **Viking Range Corporation, its subsidiaries, affiliates, successors and assigns** any and all rights of said Releasor with respect to the Released Trademarks.

Capitalized terms not otherwise defined herein have the same meanings as are set forth in the above-described Security Agreement and said meanings and definitions are hereby expressly incorporated by reference from the copy of said Security Agreement, as now recorded at said Reel 3881, Frame 0183 in said Patent and Trademark Office.

This is a partial release only and shall in no way affect the lien and security interests created under the Security Agreement insofar as such lien and security interests relate to any property other than the Released Trademarks, nor shall this partial release affect the obligations of Viking Range Corporation to pay the indebtedness secured by the Security Agreement.
