SUPPLEMENT TO TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT

This Supplement to Trademark Collateral Security and Pledge Agreement ("this Supplement"), dated as of March 12, 2012, is delivered pursuant to (a) the Amended and Restated Revolving Credit and Term Credit Agreement dated as of March 12, 2012 (as amended, restated, modified or supplemented from time to time, the "Credit Agreement"), by and among **DAYTON PROGRESS CORPORATION, WELLS FARGO BANK, NATIONAL ASSOCIATION** (successor by merger to Wachovia Financial Services, Inc.), as administrative agent (in such capacity, the "Administrative Agent") for itself and the other lending institutions which are, or may in the future become, parties to the Credit Agreement (the "Lenders"), the Lenders, and Wells Fargo Bank, National Association (successor by merger to Wachovia Bank, National Association), as Issuing Bank., and (b) the Trademark Collateral Security and Pledge Agreement, dated as of April 21, 2008 (as amended, restated, modified or supplemented and in effect from time to time, the "Trademark Security Agreement"), by and between P.C.S. Company ("Assignor"), certain affiliates of the Assignor and the Administrative Agent which was recorded with the PTO on April 22, 2008 at Reel 003764 Frame 0356. The undersigned hereby agrees that this Supplement may be attached to the Trademark Security Agreement and made part thereof. Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Trademark Security Agreement.

The undersigned agrees that that the Trademarks listed on Appendix A to this Supplement shall be and become part of the Pledged Trademarks pledged by the undersigned and referred to in the Trademark Security Agreement and shall secure all Obligations.

The undersigned hereby certifies that the representations and warranties set forth in Section 3 of the Trademark Security Agreement are true and complete in all respects with respect to the Pledged Trademarks listed below on and as of the date hereof.

This Supplement shall be governed by, and construed in accordance with, the laws of the State New York without regard to conflict of law principles thereof (other than Sections 5-1401 and 5-1402 of the New York General Obligations Law).
