RELEASE OF SECURITY INTEREST

This Release of a Trademark Collateral Agreement is made as of March 27, 2012, by U.S. BANK NATIONAL ASSOCIATION, as Collateral Agent for the Secured Parties (as defined in the Agreement described below) (the "Collateral Agent") in favor of ALVOGEN IPCO, S.a r.l. (the "Grantor").

RECITALS

WHEREAS, Grantor assigned a security interest in the trademarks described on Schedule A attached hereto (the "Trademarks") to the Collateral Agent under a Trademark Collateral Agreement dated as of November 19, 2010 (the "Agreement"), and recorded with the United States Patent and Trademark Office on November 22, 2010, at Reel and Frame Number(s) 4419/0783 and 4443/0001.

WHEREAS, Grantor has no outstanding obligations to Collateral Agent under the terms of the Agreement and Collateral Agent agrees to release its security interest in the Trademarks.

AGREEMENT

Now therefore, Collateral Agent hereby terminates and releases its security interest in, and its entire right, title and interest in and to, the Trademarks and all of the goodwill associated therewith, and reassigns to the Grantor, without warrant or recourse, all such right, title and interest of Collateral Agent in the Trademarks and all of the goodwill associated therewith.
