**TRADEMARK ASSIGNMENT**

- (c) any and all applications to register the Marks, whether state, federal or foreign;
- (d) all common law rights in, to and under the Marks; and
- (e) all other rights in, to and under the Marks, together with the goodwill of the business symbolized by the Marks.

AND FURTHER, ASSIGNOR hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
