RELEASE OF GRANT OF SECURITY INTEREST  
(U.S. TRADEMARKS)

Secured Party agrees to take such further actions, including the preparation and filing of any UCC or other release documents, to perfect the release of the Security Interest described and memorialized herein, and to provide such reasonable assistance to Borrower as may be necessary to perfect such Release.
