**FIFTH:** The Agreement and Plan of Merger as executed is on file at the principal place of business of Surviving Corporation at:

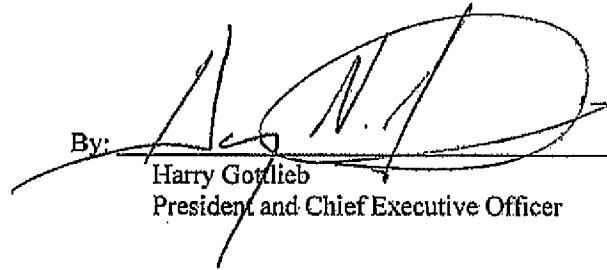
