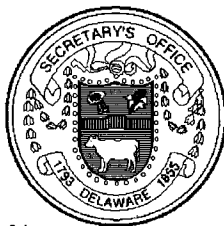

A. The original Certificate of Incorporation of the Company was filed with the Secretary of State of the State of Delaware on April 2, 1998 under its current name.

B. The amendment to the Certificate of Incorporation of the Company herein certified was duly adopted by the Board of Directors of the Company in accordance with the applicable provisions of Section 242 of the General Corporation Law and the stockholders of the Company have given their written consent in accordance with Section 228 of the General Corporation Law.
