RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of March 28, 2012 in favor of The Gordian Group, Inc. ("Grantor") by CIT Lending Services Corporation, as collateral agent (the "Collateral Agent").

WHEREAS, the Notice Letter was recorded with the United States Patent and Trademark Office on March 7, 2011, at Reel 004492, Frame 0210; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Collateral Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Trademark Collateral and (ii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark Collateral.

The Collateral Agent shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
