This transfer is effective retroactive as of date Assignor first acquired rights in the Mark.

The ASSIGNEE covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict with this Assignment;

AND the ASSIGNEE further covenants and agrees that it will cooperate in any legal proceeding, cause to be executed all lawful papers, cause to be made all rightful oaths and generally do everything possible to aid ASSIGNEE to enforce the Registration in the United States.


