Release of Lien on Trademarks

This RELEASE OF LIEN ON TRADEMARKS (this "Release") is made as of March 30, 2012, by American Capital, Ltd. (successor by merger to American Capital Financial Services, Inc.) in its capacity as agent for the Purchasers (the "Agent"), in favor of IST Acquisitions, LLC (formerly known as IST Acquisitions, Inc.), Mirion Technologies (IST) Corporation (formerly known as Imaging and Sensing Technology Corporation), Mirion Technologies (Conax Nuclear), Inc. (formerly known as IST Conax Nuclear, Inc.), I.S. Technology De Puerto Rico, Inc. (subsequently dissolved), IST Instruments Inc. (subsequently dissolved), Imaging and Sensing Technology International Corp. (subsequently dissolved) and Quadtek, Inc. (subsequently dissolved) (collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Purchase Agreement or in the Security Agreement as defined below.

WHEREAS, Grantors are party to that certain Note and Equity Purchase Agreement, dated as of May 24, 2004 (as amended, restated, supplemented or otherwise modified from time to time, the "Purchase Agreement"), among the Grantors, the Agent, and the Purchasers;

WHEREAS, Grantors are party to that certain Security Agreement, dated as of May 24, 2004 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which the Grantors executed and delivered that certain Trademark Security Agreement, dated as of May 24, 2004 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor sold, conveyed, pledged, and granted to the Agent, its successors and permitted assigns, a continuing first priority Lien on and continuing and unconditional security interest in, all of its right, title and interest in, to and under the Trademark Collateral, whether then owned or thereafter created or acquired solely to the extent constituting Collateral of Grantors, and including, but not limited to those trademarks set forth on Schedule A hereto, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of the Grantors (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 11, 2004 at Reel 2991, Frame 0724; and

WHEREAS, the Agent acknowledges full performance of the Obligations, and accordingly has agreed to release the grant of its Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, and to reconvey any and all rights in the Trademark Collateral to the Grantors;


NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases, relinquishes and discharges, without representation, recourse or warranty whatsoever, with respect to each Grantor, all of its continuing first priority Lien on and continuing and unconditional security interest in, all of its right, title and interest in, to and under the Trademark Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Trademark Security Agreement, and the Agent hereby reassigns all such right, title and interest (if any) that the Assignee may have in the Trademark Collateral to the Grantors.

The Agent agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released Trademark Collateral.
