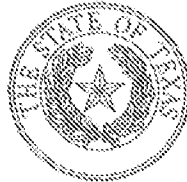





**AGREEMENT
AND
PLAN OF MERGER**

This Agreement and Plan of Merger (this "Agreement") is effective as of January 1, 2010, by and between Western Blue Print Company, LLC, a Missouri limited liability company (the "Merging Company") and Ridgway's, LLC, a Texas limited liability company (the "Surviving Company").

1. Effective as of the Effective Date, the Merging Company shall be merged into and with the Surviving Company with the surviving entity being the Surviving Company (the "Merger"). The name of the Surviving Company shall be unchanged following the Effective Date of the Merger.
2. Reprographics Fort Worth, Inc., a Delaware corporation ("Fort Worth"), is the sole member and one hundred percent (100%) owner of the Surviving Company.
3. Fort Worth is the sole shareholder and one hundred percent (100%) owner of the Merging Company.
4. The Articles of Formation and Operating Agreement of the Surviving Company that are in effect on the Effective Date of the Merger shall continue in full force and effect as the Articles of Formation and Operating Agreement of the Surviving Company following the Effective Date of the Merger.
5. As of the Effective Date, the outstanding membership interests of the Merging Company shall be cancelled and no membership interests of the Surviving Company shall be issued in exchange therefore in connection with the Merger.
6. As of the Effective Date, the outstanding membership interests of the Surviving Company shall remain outstanding and shall not be affected by the Merger. Fort Worth shall remain the sole member and owner of one hundred percent (100%) of the membership interests of the Surviving Company following the Effective Date of the Merger.
7. The Merger has been approved by the Board of Managers and the sole member of the Surviving Company.
8. The Merger has been approved by the Board of Managers and the sole member of the Merging Company.
9. The Merging Company shall from time to time, as and when requested by the Surviving Company, execute and deliver all such documents and instruments and take all such action necessary or desirable to evidence and carry out the Merger.

10. The Surviving Company shall assume all tax and other liabilities of the Merging Company as of the Effective Date of the Merger.

11. The Surviving Company shall furnish a copy of this Agreement to any member of the Surviving Company or the Merging Company upon request and without cost.

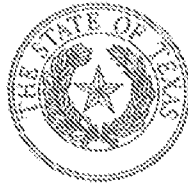
