NUNC PRO TUNC TRADEMARK ASSIGNMENT

Assignor hereby sells, assigns, transfers, and conveys to Assignee, its successors and assigns, Assignor's entire right, title, and interest in and to the Trademark, including but not limited to all common law rights associated with the foregoing, all rights of priority associated with the foregoing together with the goodwill associated with the foregoing (collectively the "Trademark"), and together with any and all rights and causes of action (including damages recoverable thereby) for past, present, and future unauthorized use of the Trademark, including but not limited to all rights and causes of action for infringement and unfair competition.

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and enforce full the benefits of the rights and interests herein sold, assigned, transferred, and conveyed. This Agreement shall be binding on the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee.

Assignor represents and warrants that it owns all right, title, and interest in and to the Trademark, that it has the authority to transfer all of the rights sold, assigned, transferred, and conveyed pursuant to this Agreement, and that it has not licensed anyone to use the Trademark in any way.

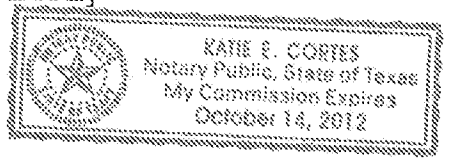

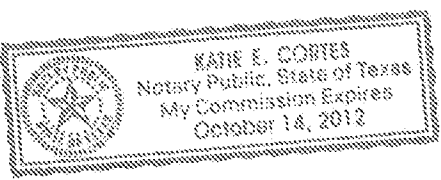
