## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 30, 2012, by PROSPECT CAPITAL CORPORATION (successor to PATRIOT CAPITAL FUNDING, INC.), as Servicer ("Servicer"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

### WITNESSETH:

WHEREAS, ROM ACQUISITION CORPORATION, a Delaware CORPORATION, ROM HOLDINGS, INC., a Delaware Corporation (collectively, the "Grantors") and Servicer are parties to a Notice of Grant of Security Interest in Trademarks dated as of August 5, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Assignment"), pursuant to which Grantors granted a security interest to Servicer in certain trademarks ("Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantors to Servicer, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on August 31, 2011, at Reel 004614, Frame 0573; and

WHEREAS, Grantors has requested that Servicer release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


