GUILD does hereby convey, transfer, assign and deliver to SAG-AFTRA, free and clear of all Liens, (i) all of GUILD's right, title and interest in and to the Assigned Marks, including the registrations and applications for registration thereof, together with all the goodwill of the business connected with the use thereof and symbolized thereby, (ii) any past, present or future claims or causes of action arising out of or related to any infringement, dilution or other violation or impairment of any of the foregoing, and the right to sue or otherwise recover therefor, and (iii) all proceeds, including license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect to any of the foregoing, the same to be held, used and enjoyed by SAG-AFTRA, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by GUILD if this Assignment had not been made.

2. GUILD shall execute and deliver, without consideration, such documents as SAG-AFTRA may reasonably request, and take any and all other actions necessary, proper or advisable to more effectively convey, transfer and assign to GUILD (or to more effectively record or evidence the same) the Assigned Marks.

3. GUILD hereby authorizes and requests that the United States Patent and Trademark Office record this Assignment.

4. This Assignment shall be governed by, and construed in accordance with, the laws of the State of California applicable to contracts executed in and to be performed entirely within that state.
