referring to your mail, dating September 26, 2011 we can confirm that aap Biomaterials GmbH (following: aap Bio) is the owner of the US Trademark US 2 947 212. aap Bio is a 100% subsidiary of aap Implantate AG (following: aap AG). aap Bio's ownership of the trademark has been a result of the following legal transactions:

1. In the year of 2000: 49% of the shares of Osartis GmbH & Co KG and 49% of the shares of the Osartis Verwaltungs-GmbH were acquired by aap AG.

Result: aap AG holds 49%-stake in Osartis GmbH & Co KG and in Osartis Verwaltungs-GmbH

Reference: certificate of registration HRA 3658 on page 3, number of the entry 3, column 5 dated June 1, 2005.

2. In the year of 2006: the remaining 51% of the shares of Osartis GmbH & Co. KG and the remaining 51% of the shares of Osartis Verwaltungs-GmbH were acquired by aap AG.

Result: aap AG holds 100%-stake in Osartis GmbH & Co KG and in Osartis Verwaltungs-GmbH.

3. In the year of 2006: Transfer of general partnership in Osartis GmbH & Co. KG from Osartis Verwaltungs-GmbH to aap Biomaterials Verwaltungs-GmbH (100% subsidiary of aap AG).

Result: aap Biomaterials Verwaltungs-GmbH is now general partner of Osartis GmbH & Co. KG.

Result: Dissolution of Osartis GmbH & Co. KG; legal successor: aap Biomaterials GmbH & Co. KG




