RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

- 1. <u>Defined Terms</u>. Unless otherwise defined herein, all capitalized terms used herein shall have the meaning given to them in the Security Agreement or the IP Security Agreement, as applicable.
- 2. Release. The Collateral Agent hereby, as of the Effective Date, releases, terminates, discharges, cancels and relinquishes the Collateral Agent's security interest, granted pursuant to the Security Agreement and the IP Security Agreement, in and to the Trademarks, including the Trademarks identified in Schedule A attached hereto.
- 3. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
