RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “Release”), dated as of April 3, 2012 (the “Effective Date”), is made by TCS Global Holdings, L.P., as agent (“TCS”), in favor of APAC Customer Services, Inc., an Illinois corporation (the “Grantor”).

WHEREAS, pursuant to that certain Reimbursement and Security Agreement, dated as of May 5, 2008, among TCS, the Grantor and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Reimbursement Agreement”), the Grantor granted and pledged to TCS a continuing security interest in and to the Collateral, as collateral security for the payment and performance in full when due of the Obligations;

WHEREAS, in connection with the Reimbursement Agreement, TCS and the Grantor also entered into that certain Notice of Grant of Security Interest in Trademarks, dated as of May 5, 2008 (the “IP Notice”), for the purposes of filing and recording with the United States Patent and Trademark Office the security interest granted with respect to the Trademarks included in the Collateral;

WHEREAS, the IP Notice was filed with and recorded by the Trademarks Division of the United States Patent and Trademark Office at Reel/Frame 3778/0620; and

WHEREAS, the Grantor has requested TCS to release the security interest held by TCS with respect to the Trademarks, and TCS has agreed to execute and deliver this Release for purposes of recordal with the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TCS agrees as follows:

1. Defined Terms. Unless otherwise defined herein, all capitalized terms used herein shall have the meaning given to them in the Reimbursement Agreement or the IP Notice, as applicable.

2. Release. TCS hereby, as of the Effective Date, releases, terminates, discharges, cancels and relinquishes TCS’s security interest, granted pursuant to the Reimbursement Agreement and the IP Notice, in and to the Trademarks, including the Trademarks identified in Schedule A attached hereto.


3. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
