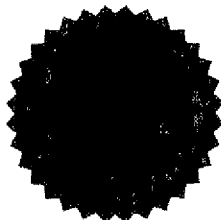

Pursuant to Section 264 of the General Corporation Law of the State of Delaware (the "DGCL"), Informatics Acquisition, Inc., a Delaware corporation (the "Company"), in connection with the merger of Informatics Acquisition GP, LLC, a Delaware limited liability company ("Informatics GP") with and into the Company (the "Merger"), hereby certifies as follows:

FIRST. The names and states of organization of the constituent entities to the Merger (the "Constituent Entities") are:

FOURTH. Article One of the Certificate of Incorporation of the Company shall be amended in its entirety to read as follows:

"ARTICLE ONE

Name

The name of the corporation is Informatics Holdings, Inc."

FIFTH. The Merger shall become effective on March ²⁵, 2005 at 12:04 A.M., Delaware time.

SIXTH. An executed copy of the Merger Agreement is on file at the office of the Company, the surviving entity of the Merger, at 1400 10th Street, Plano, Texas 75074.

SEVENTH. A copy of the Merger Agreement will be furnished by the surviving entity, on request and without cost, to any stockholder of the Company and any member of Informatics GP.
