COPYRIGHT AND TRADEMARK ASSIGNMENT AGREEMENT

THIS COPYRIGHT AND TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") shall be effective as of April 4, 2012 (the "Effective Date"), by and between Rove Mobile Inc., a corporation organized under the laws of Canada, having offices at 122 Clarence Street, Ottawa, Ontario, Canada K1N 5P6 (hereinafter, "Assignor"); and SolarWinds Worldwide, LLC, a Delaware limited liability company, having a place of business at 3711 South MoPac Expressway, Building Two, Austin, Texas 78746 ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of the registered trademarks, pending trademark applications and unregistered trademarks, and registered and unregistered copyrights listed on Schedule A attached hereto, together with the goodwill associated therewith (collectively, the trademarks are "Marks" and collectively, the copyrights are "Works");

WHEREAS, pursuant to that certain Asset Purchase Agreement among Assignor, Assignee, SolarWinds Canada Corporation and the shareholders of Assignor, dated as of February 22, 2012 and amended as of March 15, 2012, Assignor has agreed to assign and has assigned to Assignee certain intellectual property, including the specific Marks and Works set forth in Schedule A, along with any and all goodwill relating thereto; and

WHEREAS, Assignor and Assignee have agreed to enter into this Agreement as further evidence of Assignor's assignment of its rights;

NOW, THEREFORE, for good and valuable consideration already provided, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignor hereby sells, assigns, transfers and conveys to Assignee, absolutely and in perpetuity, all of Assignor's entire right, title, and interest in and to the Marks and Works worldwide, together with all of the goodwill associated therewith, and including the right to sue for and receive all damages from past infringements arising prior to the Effective Date, the same to be held and enjoyed by Assignee, its successors and assigns.

2. Assignor agrees to take all actions reasonably requested by Assignee to convey the Marks and Works from Assignor to Assignee, including but not limited to, providing specimens of the Marks and copies of the Works reasonably requested by Assignee.
