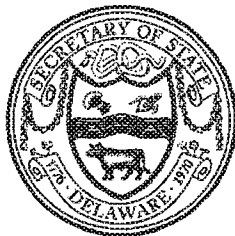

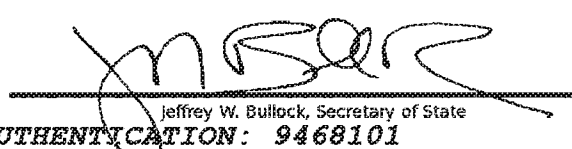

**FOURTH:** The name of the surviving Limited Liability Company is SA Environmental, LLC.

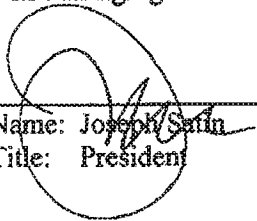
**FIFTH:** The merger is to become effective on the date of filing.
