TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made and effective as of September 28, 2011 ("Effective Date") by and between **GVI Security, Inc. ("Company")**, a Delaware corporation with its principal place of business at 2801 Trade Center Dr., Suite 120, Carrollton, TX 75007; (the "Assignor") and **NetVideo Consulting, Inc.** and **Dynacolor, Inc.** (the "Assignees"). NetVideo Consulting is a Texas corporation with its principal place of business at 221 Pecan Hollow Drive, Coppell, Texas 75019. Dynacolor is a Taiwan corporation with its principal place of business at No. 116, Jou Tz Street, Neihu, Taipei 114, Taiwan. The Assignor and the Assignees are referred to herein collectively as the "Parties".

RECITALS

WHEREAS, the Assignor has registered certain trademarks and/or service marks listed on Schedule 1 attached hereto and made a part hereof (collectively, the "Marks").

WHEREAS, it is the Assignor's intention to assign and transfer to the Assignee all of its right, title, and interest in and to the Marks; and

WHEREAS, the Assignee desires to purchase or acquire all of the Assignor's right, title, and interest in and to the Marks; and

WHEREAS the Parties are duly authorized and capable of entering into this Assignment.

WHEREAS the Assignor has agreed to sell certain assets to the Assignees pursuant to the "*Asset Purchase Agreement*", between Assignor and Assignees.

NOW, THEREFORE, in consideration of the covenants and premises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. ASSIGNMENT OF MARKS.

Effective as of the Effective Date, the Assignor sells, transfers, conveys, assigns, and delivers to the Assignees, and the Assignees accept and assume all right, title, and interest of the Assignor in and to the following:

- (a) the Marks referred to in Schedule 1 hereto;
- (b) the registrations and applications for registrations each such Mark;
- (c) the goodwill of the business connected with and symbolized by each such Mark;

- (d) all income, royalties, and damages hereafter due or payable to the Assignor with respect to the Marks including, without limitation, damages and payments for past or future infringements and misappropriations of the Marks; and
- (e) all rights to sue for past, present, and future infringements or misappropriations of the Marks.

2. ADDITIONAL DOCUMENTATION.

The Assignor will, on request:

- (a) execute and deliver, or cause to be executed and delivered, to the Assignee any additional papers, including any separate assignments of the Marks, reasonably necessary to record the assignment in the United States and throughout the world;
- (b) generally do all other lawful acts reasonable and necessary to record the Assignment in the United States and throughout the world; and
- (c) execute all lawful papers reasonable and necessary for Assignee to obtain a trademark on any of the Marks and/or on any continuing, divisional, or reissue applications thereof.

3. GOVERNING LAW.

This Assignment shall be governed by the laws of the state of Texas, without regard to conflicts of law principals thereof . In the event that litigation results from or arises out of this Assignment or the performance thereof, the Parties agree to reimburse the prevailing Party's reasonable attorneys' fees, court costs, and all other expenses, whether or not taxable by the court as costs, in addition to any other relief to which the prevailing Party may be entitled.


4. COUNTERPARTS/ELECTRONIC SIGNATURES.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument. For purposes of this Assignment, use of a facsimile, e-mail, or other electronic medium shall have the same force and effect as an original signature.
