## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made effective as of April 5, 2012, by JPMorgan Chase Bank, N.A., as administrative agent (the “Agent”) to Onex Rescare Holdings Corp., a Delaware corporation (“Holdings”), Onex Rescare Acquisition, LLC, a Delaware limited liability company (the “LLC Co-Borrower”), Res-Care, Inc., a Kentucky corporation (the “Corporate Co-Borrower” and, together with the LLC Co-Borrower, collectively, the “Borrower”), and the Subsidiaries of the Borrower listed on Schedule B hereto (such Subsidiaries, together with Holdings and the Borrower, the “Grantors”) as follows:

WHEREAS, the Grantors and the Agent are parties to that certain Amended and Restated Pledge and Security Agreement dated as of the December 22, 2010, which amended and restated in its entirety the prior Pledge and Security Agreements dated January 28, 2010 and December 31, 2003 (collectively the “Security Agreement”), pursuant to which each Grantor has granted a security interest in substantially all of its assets to the Agent for the benefit of the Agent and the Holders of Secured Obligations;

WHEREAS, the Lenders required the Grantors to execute and deliver the Amended and Restated Trademark Security Agreement dated as of December 22, 2010, which amended and restated the prior Trademark Security Agreements, dated as of January 28, 2010 and December 31, 2003 (collectively the “Trademark Security Agreement”), (i) in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations (such obligations and liabilities, as re-evidenced by the Credit Agreement, being hereinafter referred to as the “Liabilities”) and (ii) in connection with the making of any loans, advances and any other financial accommodations by the Lenders under the Previous Credit Agreement; and

WHEREAS, pursuant to said Security Agreement and Trademark Security Agreement, the Grantors granted to the Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantors’ right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the “Marks”);

WHEREAS, said Trademark Security Agreement was recorded in the United States Patent & Trademark Office on the following:

- February 6, 2004 at reel/frame 2789/0383, February 3, 2010 at reel/frame 4142/0905 and on December 22, 2010 at reel/frame 4439/0205 against Res-Care, Inc.’s Marks;
- December 22, 2010 at reel/frame 4439/0248 against Pharmacy Alternatives, LLC’s Marks;
- February 3, 2010 at reel/frame 4142/0940 and on December 22, 2010 at reel/frame 4439/0171 against Rest Assured, LLC’s Marks; and


- February 6, 2004 at reel/frame 2788/0750, February 3, 2010 at reel/frame 4142/0959 and on December 22, 2010 at reel/frame 4439/0182 against VOCA Corporation's Marks.

WHEREAS, the Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantors have satisfied their obligations under said Security Agreement and Trademark Security Agreement, the Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to the Grantors any and all right, title or interest in, or to, the Marks that the Agent may hold.
