In accordance with the requirements of the Indiana Business Corporation Law, as amended, the undersigned corporation, desiring to effect a merger, sets forth the following facts:

**ARTICLE I
SURVIVING CORPORATION**

The name of the corporation surviving the merger is Curtis Dyna-Fog, Ltd. Curtis Dyna-Fog, Ltd. was organized as an Indiana corporation on February 26, 1992.

**ARTICLE II
MERGING CORPORATION**

The merging corporation is Aire-Mate, Inc. Aire-Mate, Inc. was organized as an Indiana corporation on February 26, 1992. Curtis Dyna-Fog, Ltd. and Aire-Mate, Inc. are the only parties to the merger.

**ARTICLE III
MANNER OF ADOPTION**

Section 1. Surviving Corporation. A Plan of Merger containing the information required by Indiana Code 23-1-40-1(b) was approved by the Board of Directors of Curtis Dyna-Fog, Ltd. by unanimous written consent in lieu of a special meeting effective March 1, 2010.

Section 2. Merging Corporation. The Plan of Merger was also approved by the shareholders and Board of Directors of Aire-Mate, Inc. by a joint unanimous written consent in lieu of a special meeting effective March 1, 2010.

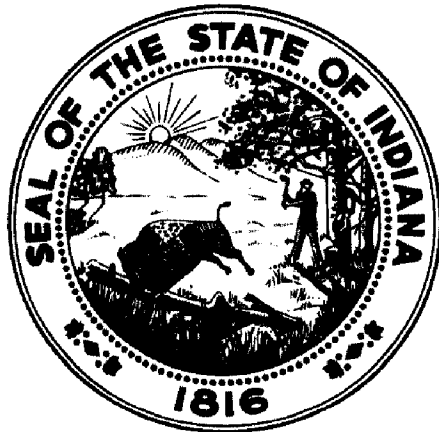
