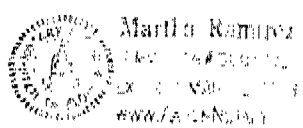
- 1. I am the managing member of PB Group LLC, a Delaware Limited Liability Company and this affidavit is based on my own personal knowledge.
