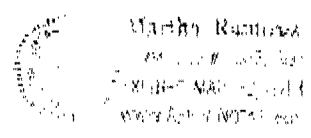
- 1. I am the managing member of PB Group LLC, a Delaware Limited Liability Company and I am knowledgeable about all facts herein.
