TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of April 10, 2012, by HELLER FINANCIAL, INC., as Agent ("Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, CAMBRIDGE INTERNATIONAL, INC. a Delaware corporation, (formerly known as Cambridge, Inc., a Maryland corporation), ("Grantor") and Agent were parties to that certain Trademark Security Agreement dated as of July 14, 2000 (the "Security Agreement"), pursuant to which Grantor granted a security interest to Agent in certain trademarks ("Trademarks") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on August 10, 2000, at Reel 2132, Frame 0807; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Rights and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) all of its Trademarks, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all reissues, continuations and extensions of the foregoing;


(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
