TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Assignment") is dated as of April 12, 2012 ("Effective Date") by and between Digital Ocean, LLC, a New York limited liability company ("Assignor") and Digital Ocean, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of the trademark identified on Schedule A attached hereto (the "Mark"), and is the owner of the registration application of such Mark in the United States Patent and Trademark Office; and

NOW, THEREFORE, for \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby irrevocably assigns, sells, conveys and transfers unto Assignee all rights, title and interests in and to the Mark, together with (i) the applications for registration and registrations of the Mark, (ii) all common law rights that Assignor may have in the Mark, (iii) the right to prosecute such applications or any new applications for the Mark and enjoy the benefits of any registrations resulting therefrom, (iv) the goodwill of the business symbolized by and associated with the Mark, and (v) the right to sue (including filing and prosecuting opposition, cancellation and similar proceedings) and recover for, and the right to profits or damages due or accrued, arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Mark or such associated goodwill. Assignor hereby requests that all appropriate trademark offices issue registrations in the name of Assignee.
2. Assignor hereby agrees with Assignee that Assignor, upon request, shall execute any and all further instruments regarding the assignments and transfers contemplated by this Assignment, which may be reasonably required in order to better secure to Assignee the use and benefit of the Mark, and that Assignor has not executed and will not execute any agreement in conflict with this Assignment. Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents, as Assignor's agents and attorneys-in-fact to act for and in behalf and instead of Assignor, to execute and file any documents and to do all other lawfully permitted acts to further the above purposes with the same legal force and effect as if executed by Assignor.
3. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
