WHEREAS, ASSIGNOR has adopted, used, and/or is using the trademarks listed in Appendix A;


WHEREAS, ASSIGNEE is desirous of acquiring said trademarks and the registrations;



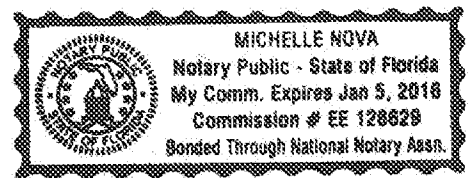
