TRADEMARK ASSIGNMENT

This ASSIGNMENT is made by **The Mason Box Company**, a corporation organized under the laws of the Commonwealth of Massachusetts, having its principal place of business at 521 Mt. Hope Street, North Attleboro, Massachusetts 02761 (the "Assignor"), and **International Packaging Corporation**, a Rhode Island corporation, having its principal place of business at 517 Mineral Spring Avenue, Pawtucket, Rhode Island 02860 (together with its successors and assigns, the "Assignee"). Assignor and Assignee are parties to a certain Asset Purchase Agreement dated as of March 7, 2012, as amended (the "Agreement").

The Assignor has adopted, owns and is using certain trademarks for which the Assignor owns the trademark applications and/or registrations and all common law rights associated therewith, which are listed in Schedule A attached hereto and incorporated herein by reference (collectively, the "Marks").

The Assignor has agreed to assign to the Assignee all of the rights, title, and interests of the Assignor in and to the Marks, and the Assignee has agreed to accept said assignment.

For TEN DOLLARS (USD) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns, transfers, and conveys to the Assignee, and the Assignee hereby accepts from the Assignor, effective as of 11:59pm on March 31, 2012, all of the rights, title, and interests of the Assignor in and to the Marks, together with the goodwill of the business symbolized by the Marks, with the right to renew any registration therefor, to be held and enjoyed by the Assignee for its own use and benefit and for the use and benefit of its successors and assigns or other legal representatives, together with the right to sue and recover for damages and profits and all other remedies for past infringements thereof.

This Trademark Assignment may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.

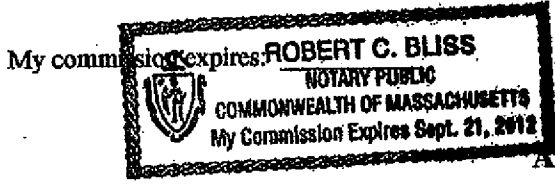
